

WEBSITE PRIVACY POLICY

Holah Logistics Pte Ltd (“Holahspace”, “we”, “us” or “our”) takes your privacy very seriously. We ask that you read this privacy policy (the “Policy”) carefully as it contains important information about what to expect when Holahspace collects personal information about you and how Holahspace will use your personal data.

This Policy applies to information we collect on www.holahspace.com and its sub-domains about:

- i) visitors to our website (the “Site”); and
- ii) people who register their emails with us.

1. INFORMATION COLLECTED FROM ALL VISITORS TO OUR WEBSITE

We will obtain personal data about you when you visit us. When you visit us, we may monitor the use of this Site through the use of cookies and similar tracking devices. For example, we may monitor the number of times you visit our Site or which pages you go to. This information helps us to build a profile of our users. 2. INFORMATION COLLECTED FROM USERS WHO REGISTER THEIR EMAILS WITH US

When you register your emails with us, we may use it for the following:

By submitting your email you consent to the use of that email as set out in this policy.

3. OUR USE OF COOKIES

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. The information is used to track visitor use of the Site and to compile statistical reports on Site activity. You can set your browser not to accept cookies and the above websites tell you how to remove cookies from your browser. However, in a few cases some of our Site features may not function if you remove cookies from your browser.

4. HOW WE PROTECT YOUR INFORMATION

We are committed to maintaining the security of personal information. We have put in place appropriate security procedures and technical and organisational measures to safeguard your personal information such as {security measures}.
